Chief Elected Officials Business Kansas Local Workforce Investment Area IV June 26, 2015 ~ Mayor Jeff Longwell, Chair

On June 01, 2015, Wichita Mayor Jeff Longwell, Chief Elected Official for Kansas Local Workforce Investment Area IV, appointed the following individuals to the Local Workforce Development Board (LWDB). The LWDB replaces the former Local Workforce Investment Board (LWIB). The terms of the appointments vary and are listed below. Beginning in 2016 terms for appointments and reappoints shall be staged to end every three years, with approximately one-third of the Board being up for reappointment each year.

The LWDB must maintain a majority, or 51 percent membership of Business/Private Sector members, and 20 percent of the Board (though no less than four) must be Labor Representatives. The CEOB strives to appoint members that represent regional demand occupations from across the region.
