

Legislative Committee Meeting Minutes

11:30 a.m., October 23, 2014 Commissioner Chip Westfall, Chair

1. Welcome

Commissioner Chip Westfall, Harvey County, welcomed attendees and asked for introductions.

2. Approval of Minutes from June 4, 2014 and September 25, 2014

Bob Myers, Newton (Mayor Terry Somers, Mount Hope) moved to approve the minutes from June 4, 2014 and September 25, 2014. Motion adopted.

3. 2015 Legislative Priorities Survey Results

The REAP Legislative Committee issued a survey to the REAP Board of Directors, members, committees, task forces and partners on October 9, 2014, soliciting feedback on legislative issues for the upcoming session. The survey closed on October 17, 2014 at noon. 36 participants responded to the survey request. The Committee discussed the results of the survey, noting that the State budget is going to be tight and very limited, so encouraging an increase in any funding is likely not going to be an option, noting that "opposing reductions" might be the better course of action. In regards to the Kansas Affordable Airfares Program (KAAP), the Committee agreed that the request should be to fund the Program as statutorily written, which includes administration of the program by REAP. The Committee agreed that the Chamber of Commerce and private business would be the best partner to lead the charge on the renewal of the program. REAP could facilitate a meeting of several business partners and other Chambers in the REAP region on potential ways to move KAAP forward in the upcoming session and the appropriate roles and responsibilities for all involved.

The Committee noted the interesting survey results from the RPS question and after lengthy discussion decided it is not an issue that will fit into the organizations 2015 Legislative Agenda. The Committee requested staff arrange for a presentation on the RPS during the upcoming year for educational purposes. The results of the Blueprint for Regional Economic Growth (BREG) study may assist in this process if it identifies a notable industry cluster in wind energy.

The City of Wichita noted that their ASR wording was changing, that their request will be to have the ASR more included in the Governor's 50 Year Vision for the Future of Water in Kansas Plan, noting that it supplies 20% of Kansas with water. Additionally the Equus beds should be more included in the Governor's Plan. Several Committee members noted that the ASR might be a good opportunity to bond with the Ag community, noting that Gerald Holmes with the Wichita Chamber has a positive, established relationship with them, and this is an issue of joint concern to all involved.

Wichita will also be asking for funding for the NEPA study for passenger rail service expansion in Kansas. T-Works funds should not be "raided" due to budget cuts and shortfalls.

The Committee noted that as some of the transportation and water issues also have federal implications, perhaps REAP should develop a separate policy statement.

Staff will draft the 2015 priorities list as a result of the meeting and will circulate it to the Committee for comment and feedback. The draft will be presented to the Board of Directors on November 7, 2014 for adoption. The infographic will be developed and presented to the Committee at the next meeting, and following approval will be printed for inclusion in the packets for the December 5th Legislative Policy Summit.
